Approval of Minutes

Ms. Zigmond moved to approve the minutes of the February 22, 2012 regular meeting of the RESA 2 Regional Council; Ms. Dickens seconded the motion; unanimously approved.

1. Adult Basic Education Status Report – Ms. Bias-Jones gave an overview of activities currently involving Adult Basic Education and how to encourage student to continue in the program through 12th grade; a summary of ABE program statistics for Region 2 was disseminated to council members; changes to GED testing/programs was explained as well as discussion of Life Skills programs at Day Count sites; proposed GED exams including scalability issues; legislative approval of one more year of GED funding.

Old Business

- 1. <u>Association of Educational Purchasing Agencies</u> Dr. Cockrille provided a handout outlining the Association of Educational Purchasing Agencies (AEPA) mission, goals, and program advantages. This handout also included a list and contact information of approved vendors. Once the contracts are signed, counties will be able to purchase for the vendor list or continue purchasing locally. Counties wishing to participate will receive training within the next month.
- 2. <u>Bus Driver Training Update</u> Dr. Cockrille gave a status update indicating that six trainers have been hired; the coordinator position has been posted and interviews will be held soon; vendors for drug testing/fingerprinting/physicals have been established and appointments are being scheduled; there are still issues with fingerprinting; however, the WVDE is working diligently with L-1 Identity Solutions to resolve these issues.

New Business

- 1. <u>Institutional Purchasing Program</u> Mr. Lucas indicated that six sites will begin purchasing through RESA 2; facilities were excited to collaborate with RESA 2 for their purchasing needs; RESA 2 will receive a 5% administrative fee for support of the project.
- 2. <u>Calendars</u> Dr. Cockrille requested counties send her their approved school calendars for 2012-2013 and consider scheduling spring breaks at the same time to allow for families that have students in one county and are employed in another county. There was a detailed discussion on the process used to determine calendars for each county and discussion on the pros and cons of OSE day placement at the end of the year.
