- 2. <u>Executive Director Discussion</u> Dr. Cockrille discussed the following topics:
 - <u>RESA 2 Services Document</u> the document was disseminated; council members thanked RESA staff for the work that went into creating the document; a request was made that the document be placed on the RESA website for easy access by council members.
 - <u>Common Core and Service Agencies</u> Changes in the format for a regional training were discussed and support training prior to the week-long summer sessions were suggested; RESA 2 has created a Regional Common Core Working Group to share ideas and craft plans for teacher/school support for Next Generation work.
 - Meeting on Personalized Learning The council decided to create a working group on personalized learning to craft a clear definition and identify best practices to enhance efforts in schools.
 - <u>AEPA</u> WV RESAs have been approved as a member; more information will be obtained over the next few months; a purchasing coordinator will probably be hired for RESAs; local vendors will be included in the bidding process; food service will not be included.
 - <u>Bus Driver Training</u> a meeting has been scheduled for Tuesday, December 20th at the RESA office at 9:30 a.m.; counties should send their transportation director as well as other staff they choose to attend this meeting.
